The *Keep 43 Committee of Canada* has seen a rise in organizations embracing bad science to promote harmful policies.

The organizations listed herein support Senate Bill S-206 (a.k.a. “Repeal 43”) commonly referred to as, “An Act to Criminalize Traditional Parenting Systems”.

Five decades of parenting system research confirm that the systems these entities want to criminalize actually produce the best developmental outcomes from the entire parenting-system matrix.

The last decade has produced an enormous body of evidence highlighting the ten harms inflicted on children, family and societies who’ve legislatively imposed this ideology.

We believe any organization who promotes harm on children under the guise of advocating for them is reprehensible. We also believe that organizations whose stated policy is to harm children via legislation should not retain a charitable status for tax reasons.

We ask those *genuinely* concerned about child welfare and the family review this list and boycott any organization who participates in this assault on the family. Further, if your child attends any of these, for your family’s safety, you should seriously consider removing them.

## **Organizations that support Senate Bill S-206 (a.k.a. "Repeal 43") *commonly called an "Act to Criminalize Traditional Parenting"***
